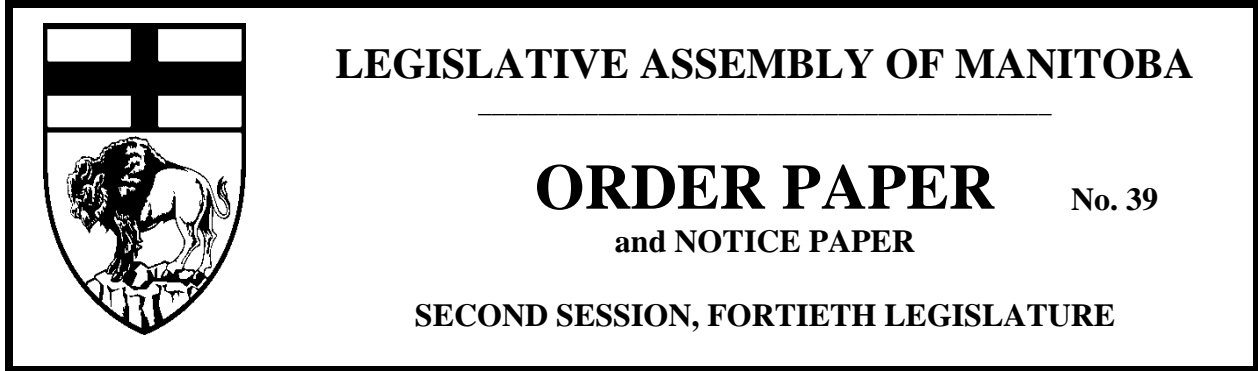

**RESOLUTION:**

**Mr. SCHULER – Manitoba Hydro Rate Hikes**

6. WHEREAS Manitoba Hydro's electricity rates increased by 8% over the last twelve months; and

WHEREAS electricity rates are expected to double over the next 20 years due to annual increases of 4%; and

WHEREAS the Public Utilities Board has expressed concerns about potentially larger than anticipated costs at Manitoba Hydro which could result in the possibility of more rate increases in the future.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba acknowledge that these rate hikes compound the financial hardship on Manitoba families imposed by the Provincial Government through tax and fee increases.
