In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

THE MINNEDOSA FISH ENHANCEMENT COMMITTEE; "the Licencee"

for the construction and operation of the Development being a bank stabilization and fish habitat enhancement project on the Little Saskatchewan River in N 3-15-18W in the Rural Municipality of Minto subject to the following specifications, limits, terms and conditions:

SPECIFICATIONS, LIMITS, TERMS AND CONDITIONS

1. The Licencee shall construct the Development in accordance with the Environment Act Proposal dated December 13, 1995.
2. The Licencee shall, prior to commencing construction activities on the Development, apply to the Canadian Coast Guard for a Work Assessment.
3. The Licencee shall not undertake instream construction or maintenance works between April 1 and June 15 of any year.
4. The Licencee shall notify Wes Burton, property owner, (204-359-6356) not less than two weeks prior to commencing construction activities.
5. The Licencee shall not undertake construction and maintenance activities during heavy precipitation events when water erosion and sedimentation adjacent to the worksites could occur.
6. The Licencee shall ensure that the clearing of streambank vegetation to provide access to the Development is minimized. Access routes shall be designated to the contractor in advance by the representative of the Licencee who is responsible for the supervision of work activities.
7. The Licencee shall, during construction and maintenance of the Development, ensure that appropriate measures are taken to prevent the entry of riverbank material and sediment due to water erosion into the Little Saskatchewan River.
8. The Licencee shall protect streambanks, disturbed by construction and subject to water erosion, with riprap. Other exposed soil shall be reseeded with a mixture of native or introduced grasses or legumes.
9. The Licencee shall ensure that instream watering facilities for cattle are constructed with slopes not greater than six horizontal to one vertical, and that these facilities are covered with material which will remain stable during use by cattle and during high velocity flow events.
10. The Licencee shall ensure that all used oil products and other regulated hazardous wastes generated by the machinery used in the construction of the Development are collected and disposed of in accordance with applicable Manitoba Environment and legislation requirements.
11. The Licencee shall ensure that fuel storage areas established for the construction of the Development are located a minimum distance of 100 metres away from any waterbody, and shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products*.

REVOCATION

If, in the opinion of the Director, the Licencee has exceeded or is exceeding the limits, or has not complied or is not complying with the specifications, terms or conditions set out herein, the Director may revoke this Licence either temporarily or permanently.
