

## AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and CENTRAL GRAIN COMPANY LTD., Applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, Central Grain Company Ltd. filed an application with the Department of Mines, Resources and Environmental Management in connection with the expansion and continued operation of an existing feed mill located at or near 172 Archibald Street, Winnipeg, Manitoba;

AND WHEREAS in the absence of limits being prescribed by a Regulation under the said Act, the application was referred to The Clean Environment Commission for the prescribing of limits;

AND WHEREAS representations were made by persons who are, or who are likely to be, affected by an Order of the Commission prescribing limits in connection with the said operation;

AND WHEREAS the Commission held public hearings on the 17th day of May, 1976, and on the 29th day of November, 1976;

AND WHEREAS the Applicant gave assurance to the Commission that Central Grain Company Ltd. will:

- (a) provide adequate sampling ports with safe sampling platforms, safe access to the sampling platforms and ready access to electrical power supply points to operate sampling equipment;
- (b) intensify maintenance programs to repair equipment and prevent the leakage of dust and grain to the atmosphere; and
- (c) ensure the appropriate training programs and operating procedures are adopted to improve plant housekeeping and prevent the malfunctioning of equipment and the release of pollutants;

AND WHEREAS the Commission considered the application on the 10th day of January, 1977;

## IT IS HEREBY ORDERED THAT

1. The Applicant shall ensure that particulate emissions from any stack or vent are not in excess of 0.23 grams per standard cubic meter calculated at 25 degrees Celsius and 760 millimeters of mercury at the point of emission.

2. The Applicant shall ensure that particulate emissions or the wind entrainment of dust from any source in the said operation do not become airborne to such an extent as to create a haze in excess of 5 percent opacity at any point beyond the property line of the said operation.
  
3. The Applicant shall ensure that a high standard of housekeeping and equipment maintenance is maintained in such a manner as to ensure:
  - (a) malfunction breakdowns and leakages affecting emissions to the environment are repaired promptly; and
  - (b) the exterior of the structures and appurtenances of the said plant and the grounds on the site of the said operation are kept free of accumulations of grain, grain by-products and associated dust.
  
4. Order No. 274 issued on the 25th day of May, 1974, is hereby rescinded.
