AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION
UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and STEFANCHUK LUMBER COMPANY LTD.,
Applicant,

- WHEREAS pursuant to Section 14(1) of The Clean Environment Act, Stefanchuk Lumber Company Ltd. filed a proposal with the Department of Consumer and Corporate Affairs and Environment in connection with the alteration and continued operation of a facility for the loading of cement, sand and aggregate into mobile concrete mixers located at or near 2445 Ferrier Street in the City of Winnipeg, Manitoba, the alteration being in connection with the addition of a second cement silo to the operation;
- AND WHEREAS in the absence of limits, terms and conditions prescribed by a regulation under the said Act, the proposal was referred to The Clean Environment Commission for the prescribing of limits, terms and conditions;
- AND WHEREAS after giving notice, the Commission received representations from persons who are likely to be affected by an order of the Commission issued in connection with the said operation;
- AND WHEREAS the Commission held a hearing in Winnipeg on the 2nd day of March, 1981, to receive evidence and representations in connection with the said proposal;
- AND WHEREAS the Commission considered the proposal on the 16th day of March, 1981;

IT IS HEREBY ORDERED THAT


1. The Applicant shall, on and after the 1st day of May, 1981, limit particulate emissions from the various processes of the said operation to the extent that such emissions do not at any time exceed a concentration of 0.57 grams per standard cubic metre calculated at 25 degrees Celsius and 760 millimetres of mercury when measured at the point of emission.
2. The Applicant shall, on and after the 1st day of May, 1981, limit visible emissions from any process of the said operation to such an extent that such emissions:

2. (a) do not exceed an opacity which is equal to or greater than 40 percent for a period exceeding four continuous minutes in any one hour at the point of emission;
- (b) do not exceed an opacity which is equal to or greater than 60 percent at any time at the point of emission.
3. The Applicant shall, on and after the 1st day of May, 1981, control particulate emissions from the said operation to such an extent that airborne particulate matter does not at any time exhibit an opacity greater than 5 percent past the property line of the said operation.
4. The Applicant shall at all times carry out a high standard of equipment maintenance and housekeeping practices in order to comply with the limits prescribed in this order.
