On behalf of the members of the Red-Seine-Rat Wastewater Co-operative (RSRWC), we are requesting an adjustment to the lagoon effluent discharge period for the member communities listed in Table 1. The requested adjustment is to the SPECIFICATIONS, LIMITS, TERMS AND CONDITIONS section of the licences.

The requested revised discharge period for the communities listed in Table 1 is between May 15th and November 30th.

This adjustment is requested to increase the RSRWC members' treatment flexibility for the next 3 years as it allows a short-term increase in the lagoon capacity for each community while the regional RSRWC wastewater treatment plant is designed, constructed, and commissioned. Once the regional wastewater treatment plant is online, the lagoons will be repurposed and no longer used for treatment. The details regarding the changes to the lagoons will be provided in a separate environment act proposal.

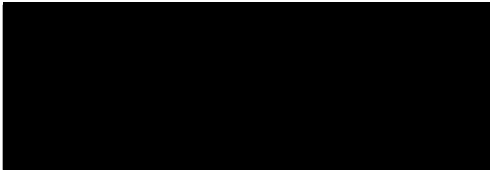
Subject: Request for Adjusted Lagoon Effluent Discharge Periods in 2023 to 2026

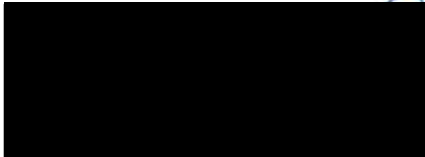

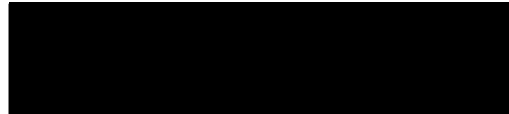
