Re: Urbanmine Inc. – Request for an Extension to Complete Noise Mitigation Environment Act Licence No. 3199 R – Clauses 36 and 37

Environment, Climate, and Parks acknowledges receipt of your letter dated October 28, 2022 requesting an extension of time to complete implementation of the noise mitigation measures approved under Clause 36 of the licence and to discontinue the noise pollution monitoring plan approved under Clause 37 of the licence.

Upon review, pursuant to Clause 36 of Environment Act License No. 3199 R, approval for an extension of time to conduct point source monitoring of noise sources at the development upon commissioning of the new processing lines, update the noise modelling, and develop an optimized Noise Abatement Action Plan for the development is granted subject to the following conditions:

1. Provide written notification to the Director within 14 days of completing each of the ferrous and nonferrous equipment commissioning tests as per Clause 8 of the licence. Please note that in accordance with the above licence, "commissioning" means when the process of all systems and components of each of the ferrous and nonferrous equipment installed are tested according to the operational requirements and ready for the intended operation.
2. Provide written notification to the assigned Environment Officer five days in advance of conducting the point source noise monitoring.
3. Submit the noise modelling results and the Noise Abatement Action Plan complete with details of the proposed mitigation measures and the corresponding implementation timeline to the department for review and approval by May 31, 2023.

4. The Noise Abatement Action Plan must include technical details of all proposed new mitigatory measures and any upgrades to existing mitigation measures including design and other specifications.

Further to the above, the Noise Pollution Monitoring Plan approval letter issued on September 17, 2021 under Clause 37 of the licence is hereby cancelled. Urbanmine will be required to submit an alternative follow-up noise pollution monitoring plan prepared by a qualified consultant to verify the effectiveness of the implemented mitigation measures in a timeframe to be determined by the Director following the submission of the Noise Abatement Action Plan.
