Hello Bruce:

On behalf of the Water Quality Management Section of Manitoba Sustainable Development I reviewed the proposal pursuant to the Environment Act for rural water supply in the R.M of Rosedale – Your file 5846.00. Based upon review of the proposal I did not identify any outstanding concerns with respect to surface water quality that could not be resolved using appropriate best management practices and mitigation measures in construction and operation of the water supply development.

The following recommendations could be considered as part of a potential Environment Act License for this project.

- Should any chlorinated water have the potential to enter surface water bodies it should be de-chlorinated prior to release and in compliance with the Manitoba Water Quality Objective for total residual chlorine.
- A procedure be implemented to respond to accidents/ malfunctions during construction including potential frackouts when directional drilling, erosion, and spills of fluids from machinery. Appropriate materials to respond to emergency events should be on site at all times.
- Clearing of vegetation adjacent to water bodies be minimized. Effective erosion controls should be used to prevent sediment from entering water bodies
- Any areas of soil or vegetation that are disturbed during construction should be stabilized and replanted using a seed mix appropriate for the area
- Any water crossings should be directionally bored as opposed to open cut.

The *Water Control Works and Drainage Licensing Section* recommends the following:

- 1) All works are constructed in accordance with *Fisheries and Oceans Canada - Operational Statements*.
- 2) The construction schedule avoids critical fisheries time periods of April 15<sup>th</sup> to June 15<sup>th</sup>.
- 3) The timing of construction is aimed at eliminating, reducing, or preventing erosion.
- 4) Construction activities are suspended during wet conditions, and performed only during low or no-flow periods.

Please remind the proponent that any water control works (drains, culverts, dykes, dams, etc.) associated with this project will require licensing under the *Water Rights Act* – an application is attached for the proponent's convenience.
